(d) The officer was under suspension from 15.2.2018 and he expired while under suspension on 20.6.2018. He was paid subsistence allowance as admissible.

(e) The officer has at his credit 258 days earned leave and 100 days half pay leave.

(f) The pay of the officer from 1.1.2016 was Rs.78,800/- in Level 12 in the pay matrix with DNI on 1.7.2016.

[As per 7th CPC pay matrix, Downward cells of Level-12 Pay matrix is 78,800, 81200, 83600, 86100, 88700, DA as on 1.1.2018- 7%]
